**HORSE RENTAL CONTRACT AND RELEASE**  
**(Lease Agreement)**

I, \_\_\_\_\_ (Lessee), agree to rent from **Sombrero Ranches, Inc.** (hereinafter  
PLEASE PRINT NAME)

referred to as "Sombrero"), 911 Kimbark Street, Longmont, CO 80501, \_\_\_\_\_ horses.

Upon taking possession of these horses, I understand and agree to assume full responsibility for them. I shall provide hay and grain in sufficient amounts to return the animals in the same or better state of health than they were in when I received them. Sombrero's agent shall be the sole judge in this matter. I shall maintain proper shoes on each animal. In the event that the horses are injured or that I am unable to return them in the same condition they were in when received, I shall pay Sombrero the sum of Six Hundred Dollars (\$600.00) for each injured horse or each horse returned in less condition than when received. For each dead horse, missing horse, or horse on which euthanasia must be used, I shall immediately pay the sum of Twelve Hundred Dollars (\$1,200.00).

If any equipment furnished with the horses is damaged or lost, I shall replace it with equipment of like value, or I shall pay for it at the following rate: saddle \$600.00; bridle \$30.00; halter \$15.00; saddle blankets (2) \$30.00 each. Sombrero may repair or have repaired any of the above equipment and I shall pay for these repairs up to the above stated values.

**Injured or Damaged Horses:** Lessee returning horses with bad wither sores, kidney sores, or in poor physical health shall be charged \$600.00 for each unusable horse. It is also understood that Sombrero will not be responsible for any veterinarian costs, veterinarian supplies, extra labor expenses, and income loss due to injured horses and that **all expenses** are the responsibility of the Lessee.

**Horse Health:** Sombrero makes every effort possible to ensure the delivery of healthy horses. However, due to the fact that Sombrero is in the business of leasing horses, as well as purchasing horses from many locations throughout the western United States, Sombrero makes no guarantees to the possibility of herd health risks associated with our horses. It is agreed by the Lessee that Sombrero will not be held responsible for any losses due to unknown health problems at the time of delivery or during the rental period. It is further agreed that Lessee understands the risk involved with horse health and agrees to accept those risks.

**Care of Horses - YOU ARE RESPONSIBLE FOR SUPPLYING FEED FOR YOUR HORSES:**

1. Minimum feed per day per horse:
  - A. 25 lbs. of good hay so they will perform well. (NOTE: If hunting in the wilderness area, i.e., Flattops, you will need to purchase hay-alfalfa cubes. Bringing bales of hay is prohibited.) Colorado now requires the use of Certified Weed Free Hay on all its National Forest & BLM grounds.
  - B. 1 gallon of grain morning and night (good mix). Recommended: 3-way 12% protein mix.
2. Horses must be watered at least twice per day whether used or not, and more often if used.
3. Horses must be unsaddled and unbridled **every** night.
4. Do NOT run horses up hills.
5. Do NOT pack over 200 pounds per horse; do NOT pack antlers on any horse.
6. Should horse develop saddle sores, do not use until sore is healed.
7. Do not ride horses double (2 people).

I, the Lessee, have read and fully understand Sombrero's Injured or Damaged Horse, Horse Health, Death of Horse, and Care of Horses Policy.

I agree to be responsible for the safety and supervision of any person(s) riding or using said horses, acting in the capacity of agent for such person(s), during the term of this Lease Agreement, and Sombrero shall not be held liable for any claims which may be brought by any person or persons for the use of said horses. I agree that I shall hold Sombrero harmless and shall indemnify Sombrero against such claims, if any. Sombrero shall be named as an additional insured in the liability insurance policy in an amount not less than \$500,000 per person. I agree to adhere to the provisions of Colorado Revised Statute 13-21-119 regarding liability risk inherent to equine activities.

I understand that:

1. A sum of Three Hundred Dollars (\$300.00) shall be deposited for each one to three horses rented.
2. This **SECURITY DEPOSIT IS SEPARATE** from the rental fee, but may be paid with the same check.
3. The deposit will be returned by check at close of the hunting season from the Longmont office (near the end of December), provided the following conditions are met:
  - a. I pick up the horses or I am at the delivery location as specified in this contract.
  - b. I stay with the horses until they are picked up by Sombrero
  - c. I return the horses and equipment in satisfactory condition.
  - d. I return the **Horse Rental Contract and Release** properly signed and dated by any and all persons before riding the horses or using the equipment, affirming that they have read and agreed to the terms of the **Horse Rental Contract and Release**, assuming the risks of hunting horse rentals and releasing Sombrero from liability, including negligence.
4. **Rental fee is to be paid in advance of delivery, due in the Longmont office by October 1st for the first two elk and deer seasons; October 20th for the third and fourth seasons.**
5. **Absolutely no horses will be reserved for 1st season unless deposit & rental fees are paid in full by October 1.**
6. **I WILL REMAIN WITH THE HORSES UNTIL SOMBRERO PICKS THEM UP REGARDLESS OF TIME; IF I AM NOT PRESENT I WILL SURRENDER MY DEPOSIT.**

**NOTE:** Forest Service regulations require Sombrero to have a permit to deliver horses in the National Forest. We will advise you of our ability to deliver to your site.

**RIDER'S AGREEMENT TO ASSUME THE RISKS OF HUNTING HORSE RENTALS AND RELEASE  
SOMBRERO RANCHES, INC. FROM LIABILITY, INCLUDING NEGLIGENCE**

THE RENTER AND/OR RIDER BY SIGNING HIS/HER NAME AT THE BOTTOM OF THIS RELEASE, AGREES THAT FOR AND IN CONSIDERATION OF THE OPPORTUNITY TO RENT AND/OR RIDE A HORSE OF SOMBRERO (HEREINAFTER CALLED SOMBRERO), HEREBY AGREES TO HIRE THE HORSE FOR THE ABOVE STATED ACTIVITY AND FURTHER AGREES AS FOLLOWS:

(1) THAT SOMBRERO, ITS AGENTS, SERVANTS OR EMPLOYEES, HAVE EXPLAINED TO ME THAT SOMBRERO'S DUTY TO THE PUBLIC REQUIRES THEM TO DESCRIBE THE NATURE OF THIS SERVICE PERFORMED HERE IN PROVIDING A HORSE FOR MY USE, THAT I CLEARLY UNDERSTAND THE FAIRNESS AND MEANING OF THIS RELEASE AGREEMENT, AND I ACKNOWLEDGE THAT I HAVE BEEN GIVEN AN OPPORTUNITY TO ASK ANY QUESTIONS CONCERNING THIS MATTER;

(2) THAT I KNOW AND UNDERSTAND THAT THIS HORSE RIDING ACTIVITY INVOLVED SPECIFIC RISKS OF PROPERTY DAMAGE OR PERSONAL INJURY TO ME OR TO MY MINOR CHILDREN ARISING FROM APPROACHING, HANDLING, MOUNTING, RIDING AND DISMOUNTING THE HORSE AND FROM OBSERVING OR PARTICIPATING IN THIS ACTIVITY, INCLUDING THE RISK THAT SOMBRERO OR ITS SERVANTS, AGENTS OR EMPLOYEES MAY ACT **NEGLIGENTLY** IN SELECTING, PREPARING OR MAINTAINING THE HORSE(S), EQUIPMENT OR PREMISES, IN ASSISTING ME OR MY MINOR CHILDREN TO MOUNT OR DISMOUNT FROM THE HORSE, OR IN OTHERWISE SUPERVISING THE ACTIVITY: **BUT THAT I NEVERTHELESS INTENTIONALLY AGREE TO ASSUME THESE RISKS;**

(3) THAT I HEREBY RELEASE AND FOREVER DISCHARGE SOMBRERO, ITS AGENTS, SERVANTS OR EMPLOYEES FROM ALL PRESENT AND FUTURE CLAIMS ARISING FROM PERSONAL INJURY OR PROPERTY DAMAGE SUSTAINED BY ME OR BY MY MINOR CHILDREN DURING THE USE OF THE HORSE OF SOMBRERO, **WHETHER OR NOT LOSS, DAMAGE OR INJURY RESULTED FROM THE NEGLIGENCE OF SOMBRERO**, ITS AGENTS, SERVANTS OR EMPLOYEES AND SOMBRERO'S FAILURE TO USE DUE CARE, EITHER IN ITS TRAINING METHODS OR IN ITS FURNISHING SAFE EQUIPMENT, AND I SHALL ASSUME ALL RISKS RELATED TO HORSEBACK RIDING;

(4) THAT I WAIVE MY RIGHT TO FILE AND PROMISE NOT TO FILE ANY LEGAL PROCEEDINGS AGAINST SOMBRERO, ITS AGENTS, SERVANTS OR EMPLOYEES, FOR ANY PERSONAL INJURY OR PROPERTY DAMAGE SUSTAINED BY ME OR BY MY MINOR CHILDREN DURING THIS ACTIVITY, **INCLUDING DAMAGE ARISING OUT OF NEGLIGENCE** BY SOMBRERO, ITS AGENTS, SERVANTS OR EMPLOYEES; AND I SHALL PAY ALL COSTS AND ATTORNEY'S FEES FROM ANY LEGAL PROCEEDINGS WHICH I MAY BRING CONTRARY TO THIS AGREEMENT AND WHICH IS RESOLVED IN FAVOR OF SOMBRERO, ITS AGENTS, SERVANTS OR EMPLOYEES.

(5) THAT I SIGN THIS RELEASE AGREEMENT FOR AND IN CONSIDERATION OF THE AGREED PRICE, AND I HEREBY REQUEST SOMBRERO, ITS AGENTS, SERVANTS OR EMPLOYEES, TO CHOOSE FOR ME OR FOR MY MINOR CHILDREN A HORSE FOR THE PURPOSE OF RIDING SAME, KNOWING THAT SOMBRERO, ITS AGENTS, SERVANTS OR EMPLOYEES ARE RELYING UPON THIS RELEASE AGREEMENT AND THE INFORMATION THAT I HAVE GIVEN TO THEM CONCERNING MY EXPERIENCE AND THAT OF MY MINOR CHILDREN WITH HORSES, INCLUDING THE POTENTIAL HAZARDS INVOLVED;

(6) THAT I WILL PAY THE CONTRACT RENTAL FEE FOR THE USE OF THE HORSE(S) OR EQUIPMENT FURNISHED TO ME BY SOMBRERO; AND THAT I WILL PAY ANY CHARGES WHICH MAY BE ASSESSED AGAINST ME FOR OVER-RIDING, ABUSING OR WILLFULLY MISTREATING THE HORSE(S) RENTED TO ME, AS WELL AS THE FULL COST OF REPAIRING OR REPLACING HORSES OR EQUIPMENT DAMAGED OR LOST BY ME.

(7) **THAT I HAVE READ THE FOREGOING RELEASE, AND BEING OF SOUND MIND AND AN ADULT, SIGN IT FREELY WITH FULL KNOWLEDGE OF ITS MEANING AND CONTENT.**

**WARNING**

Under Colorado law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to section 13-21-119, Colorado Revised Statutes.
